2. Haripur Municipality, Haripur Sarlahi invites electronic bids from eligible bidders for the construction of black top road under National Competitive Bidding - Single Stage single Envelope Bidding procedures.

6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on 2077/11/2 at the office of Haripur Municipality, Haripur Sarlahi. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid\amounting to a minimum of NRs 380000.00 which shall be valid for 30 days beyond the validity period of the bid.
